

Gore Hill County Water District Newsletter Mar 2022

Project Update

The new wells project was advertised requesting bids by the 4th of April. A Contractor's pre-bid meeting was held on March 28th with a question and answer session being provided. Separate sealed bids for construction of the Gore Hill Water System Improvements will be received by the Gore Hill Water District at the office of Great West Engineering, 2501 Belt View Drive, Helena, MT 59601 until 2:00 p.m. local time on April 4, 2022 and then publicly opened and read aloud.

The project consists of drilling two new wells replacing the existing water supply wells, relocating the gas chlorination systems adjacent to the treatment buildings, installing an automatic transfer switch on the existing backup generator, installing a radio telemetry system and dialer for the water system, installing two pressure sensing points in the distribution system, lining the interior of the concrete tanks with an elastomeric urethane coating and installing polyphosphate chemical feed equipment in both treatment plants. The district once again applied for American Rescue Plan Act 2021 funding both through Cascade County and the State of Montana; Cascade County has pledged \$277,250. We have not received word yet as to how the district rated in the round 2 ARPA funding. As has been previously discussed and reiterated – WE ARE ON BORROWED TIME WITH THE 50-YEAR-OLD EXISTING WELLS CURRENTLY IN USE. The project is currently at \$1,100,000 for completion. If the district does not receive any grants, each current customer will be looking at approximately a \$26/month flat rate increase to fund

System Leak

Unfortunately, it appears that there is a leak/leaks within the water

district system. We are losing approximately 200,000-300,000 gallons per month that we cannot account for. Please, if you see water standing or notice anything unusual with your water, notify the district at once. Since the water does not always surface leaks can be very difficult to locate. We purchased equipment to help in the location of leaks.
