Project Completed

The good news is that the project to improve our water district is completed. The project was covered by loan through the Environmental Protection Agency's Drinking Water State Revolving Funds program. The loan amount is \$1,509,000 with an interest rate of 2.5%. The period of the loan is January 1, 2024, to July 1, 2053. Each member of the district is paying a bond repayment of \$26.00.

Please be aware also – the district does not have the water right to bring on more taps/customers other than the original 266 which were part of the original design. We do not have the water for existing lots to be subdivided and receive a tap!

System Leak

Please, if you see water standing or notice anything unusual with your water notify the district at once. Since the water does not always surface leaks can be very difficult to locate. Leak location equipment has been purchased and the operator will be assessing the system.

Water Outage

Gore Hill County Water District uses variable speed pumps to distribute water to our customers. When we have power outages, our pumps go down and the system loses pressure. Please be aware our pumps work off 3 phase commercial power. This means you might have power

returned to your home, but we will not have all 3 legs of power to run our pumps. If you have water outage, please call 406-560-3142 so we can respond. Posting on Facebook does not notify us like a phone call.
